

## New York State Department of Motor Vehicles - Boat / Vessel Registration Information

### Instructions to Use This Table:

Find the information for your boat in each column under “Current Status of Boat.” Use the row that contains all the correct information for your boat. Under “Registration Documents,” find information about the proofs of ownership you must bring to the DMV office and information about the type of proof of ownership the DMV office will issue.

- Remember that you must also show proof of [sales tax payment, purchase price or exemption](#) when you register a boat.
- HIN indicates Hull Identification Number. USCG indicates US Coast Guard.
- Contact the US Coast Guard for information about the USCG forms and procedures for documented boats.
