



THIS VEHICLE MAY NEVER BE TITLED AGAIN. IT MUST BE DISMANTLED OR SCRAPPED.

This statement may be used by property owners to dispose of an abandoned vehicle in accordance with Section 1224 of the Vehicle and Traffic Law. It may be used only if the vehicle being disposed of: (1) has a wholesale value of \$1,250 or less; and (2) is ten or more model years old; and (3) has been abandoned for at least one month.

If the vehicle is less than ten years old, or if the vehicle dismantler or itinerant vehicle collector pays more than \$1,250, the vehicle dismantler or itinerant vehicle collector must obtain a title or a transferable registration from the property owner.

Instructions: Please fill in all boxes, sign by the arrow at the bottom of this page, and attach a VIN tracing from the abandoned vehicle.

Within 15 days of acquiring the vehicle, the vehicle dismantler or itinerant vehicle collector will send this completed form, VIN tracing, and copy 2 of form MV-907A to:
